Compostable Materials Certification Scheme (CMCS)

#### The CCS

- As of June 2024, there were 170 certified processes on the scheme:
  - 129 in England
  - 21 in Scotland
  - 13 in Wales
  - 6 in Northern Ireland
  - 1 in Republic of Ireland
- ~4.1 million tonnes per annum of inputs
- ~2.0 million tonnes per annum of quality compost



#### The BCS

- As of June 2024, there were 106 certified processes on the scheme:
  - 79 in England
  - 12 in Scotland
  - 7 in Wales
  - 8 in Northern Ireland
- ~5.6 million tonnes per annum of inputs
- ~4.9 million tonnes per annum of certified digestate



#### The Research Hub

- Funded by CCS and BCS producers and operators, the Research Hub was set up with the aim to generate scientific evidence to support innovation and contribute to the development of the Schemes, Standards, and End-of-Waste Frameworks.
- Completed projects:
  - The Research Library
  - Digestate Characteristics and Valorisation Options
  - Carbon Accounting for Compost and Digestate
- Ongoing projects:
  - Risk assessments updates for compost and digestate to inform Compost Quality Protocol and AD Quality Protocol revision
  - Plastic contamination method assessment
  - Plant response test interpretation and comparison

### Future Research Hub Projects

- Current evaluation for 2024 projects is ongoing and looking to conclude very soon
- Potential follow-on from the Carbon Footprinting Project:
  - Previous project resulted in the development of a report on how an operator could conduct a Carbon Footprinting assessment for their site
  - The Research Hub is considering developing this report into a more user-friendly tool
  - Part of this discussion is looking to explore whether this would be valuable to operators
